3. APPLICATION FEES & MODE OF PAYMENT:

- General/OBC Category : Rs 1500/-
- SC/ST/EWS Category : Rs 1200/-
- Ex-servicemen/Women/PwBD candidate is exempted from any fee.

Application fee is required to be remitted through Demand Draft only. The **Demand Draft should be drawn in favour of AIIMS, Patna payable at AIIMS, Patna**. Any other instrument of payment is not acceptable. The application fee is non-refundable.

4. FILLING UP OF APPLICATION FORM ON THE DATE OF WALK-IN INTERVIEW:

- a) For filling up of application on the date of walk-in interview, the candidates have to bring the following documents (**original and one set of self-attested copies**) which also needs to be produced at the time of walk-in interview:-
- Recent Passport size photograph of candidate
 - face clearly visible
 - The picture should be in colour, against a light-coloured, preferably white background
 - Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
 - Demand Draft in original (if applicable)
 - Aadhar Card
 - Date of Birth/SSC/HSSC pass certificate (mentioning Date of Birth)
 - MBBS Degree Certificate
 - Internship Completion Certificate
 - MD/MS/DNB/DM/M.Ch Degree/Provisional Degree Certificate
 - UG & PG NMC/State Registration Certificate
 - Category/PwBD Certificate (If seat is claimed in reserved category)
 - Experience Certificate, if any
 - NOC from present employer (applicable for those working in Govt./Pvt. organization)
 - Demand Draft in original
 - Any other relevant documents (viz. Research Work, Publication etc.)
- b) The candidates are requested to fill the correct details regarding name/age/gender/caste/address/educational qualification and other relevant fields mentioned in the application form.
- c) Once form is submitted, there shall be no provision for making changes in the application form.
- d) Payment of application fees by any other mode viz. Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Executive Director, AIIMS Patna in this regard shall be final and binding.

5. RESERVATION:

- The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 5% for PwBD candidates (on horizontal basis).
- **For OBC-NCL Candidates:** Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of application from **22.06.2022 to 21.06.2023 (both dates inclusive)**. Candidate must submit the OBC certificate issued by the competent authority of Govt. of India in Format given by DOPT/ Govt. of India or for the appointment to the Central Government Job.

- Qualification/Experience will be counted as on 21.06.2023.

- Eligibility is subject to verification of the documents on the day of Walk-in Interview.
