HIRING OF CONSULTANTS FOR PAIRVI WORK

Central Bureau of Investigation, Anti-Corruption Branch, Hyderabad is looking for retired Police Officers of the rank of Inspectors and above for engaging 3 Consultants for attending to the work related to CBI cases in various courts at Hyderabad, for a period of one year extendable to one more year.

2. The retired officers of the Central/State Police Forces of the rank of Inspector or above with experience in Investigation and Prosecution of Criminal Cases in the Court of Law who did not cross 65 years of age are eligible for being hired to the above mentioned post. The candidates should be Graduates from a recognised University. The candidate will be hired on whole time basis and will have no right to undertake any other part time employment during the period of hiring.

3. The monthly remuneration of a fixed amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. If the employee has availed the commuted value of pension, the commuted portion of pension shall also be included in the portion of pension to be deducted. No increment, Dearness Allowance and HRA shall be allowed during the term of the contract. An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of his/her retirement.

Incomplete applications and applications received after last date will be summarily rejected.
