- a) Appointment is purely on contract basis and the initial period of appointment of contract will be for **One Year Only**.
- b) On completion of tenure, the contract shall lapse automatically. However, the appointment can be terminated at any time by giving one month's notice (on either side) by paying/refunding one month's salary without assigning any reason or failure to complete three months service to the satisfaction of the competent authority.
- c) The appointee shall not be entitled to any benefits like provident fund, pension, gratuity, medical attendance treatment, seniority, promotion etc or any other benefits available to the Government servant appointed on regular basis. The appointee will not be granted any claim or right to regular appointment to any post under CRPF. UniqueFriends.in
- d) The working hours of the appointee as per the schedule of CRPF Hospitals/Establishment or as fixed by competent authority.
- e) The appointment carries the liability to serve in any part of the country.
- f) The appointee shall perform the duties assigned to him/her. The Competent authority reserves the right to assign any duty as and when required. No extra/additional allowance will be admissible in case of such assignment.
