Indian Navy invites applications for the posts of Boat Crew Staff classified as Group 'C', Non-Gazetted, Non-Industrial lives eligible candidates to apply online through Indian Navy website www.joinindiannavy.gov.in for the posts of Syring of Lascars, Lascari-I, Fireman & Topass. Selected candidates normally will have to serve in the only under administrative control of Headquarters, Western Naval Command, Mumbai. They can however be posted anywhere in India, or abroad under directions as per administrative requirement. The vacancy details are as follows:-

Physical requirement suitability for PwBDs - As per posts identified by Ministry of Social Justice & Empowerment notification No. 34-18-2023-DD-41 dated 04 Jan 2023 amended vide notification No. 30-722023-DD-39 dated 26 Aug 2023, the PwBD candidates belonging to following suitable categories of benchmark disability may apply for above posts accordingly:-

Persons with SLDs with associated limb dysfunction shall be covered under the respective sub category such as OI, CA etc. as the case may be.

Note: PwBD candidates must be in possession of disability certificate issued by the Competent Authority prior to applying Online in the prescribed format as mentioned at Rule 10(1) of Ministry of Social Justice and Empowerment Notification O.S.R (S) (E) dated 15 Jun 2017. Reservation: Reservation for SC/ST/OBC/EWS categories are available as per that Government Orders. The reserved vacancies will be filled up separately from amongst the eligible SC, ST, OBCs, EWS candidates which will thus comprise of SC, ST, OBC, EWS who are either lower in merit than the last candidate on merit list of UR category or SC/ST/OBC candidates who have availed age relaxation for respective category irrespective of their position in merit list. Similarly, reserved vacancies for ESM, ESM & Ex-Agrisees will be filled up from amongst such eligible candidates in respective category who are lower in merit than the last candidate on merit list of respective category but otherwise found suitable for the appointment over

* If related standard, Reservations for PwBDs, ESM & Ex-Agrisees fall under this category of horizontal reservation which covers across vertical reservation in reservation for SC/ST/OBC/EWS (What is called inter-caste reservation). The candidates selected against the PwBDs, ESM & Ex-Agrisees quota will be placed in the appropriate category of UR/SC/ST/OBC/EWS as the case may be.

4. Essential Qualification.

(b) Lascari-I	(a) 10th pass from a recognised Institute or Board. (b) Knowledge of swimming. (c) One year experience as a registered vessel.
(c) Fireman	(a) 10th pass from a recognised Institute or Board. (b) Knowledge of swimming. (c) Certificate of having completed pre-sea training course.
(d) Topass	(a) 10th pass from a recognised Institute or Board. (b) Knowledge of swimming.

Note: (a) Syring certificate granted under Inland Vessels Act, 2021 will also be accepted w Inland Vessels Act, 1917 has been superseded by Inland Vessels Act, 2021.
(b) The experience gained for the posts of Syring of Lascars and Lascari-I must be obtained on a vessel registered under Merchant Shipping Act, 1958 or Inland Vessels Act, 1917/2021 with a valid 'Certificate of Survey'. If the vessel is a fishing vessel, the vessel is to be registered and licensed as per the Marine Fishing Regulation Act, 1978 or under any of the Fishing Regulation Act of States/UTs.
(c) For the post of Fireman, the certificate of having completed pre-sea training course is required to be in a.m. Director General of Shipping (DGS) Circular No. 18 of 2020 dated 24 Apr 2020 and 01 or 2020 dated 27 May 2020. The format for course completion certificate shall be as per that mentioned at DGS Circular 20 of 2020. For certificate awarded prior to 01 Jun 2020, the certificate of being completed pre-sea training course is to be in a.m. DGS Circulars issued from time to time for that relevant period. The name and logo of the Maritime Training Institute (MTI) is to be clearly mentioned at the top of the certificate along with the MTI No. and Certificate No. The MTI is required to have been registered and approved by Director General of Shipping during the period the pre-sea training course was undertaken. The candidates are required to submit the following attachments:-
(i) Attachment 1 - Copy of the pre-sea course completion certificate (Degree/Diploma/course certificate)
(ii) Attachment 2 - Copy of the certificate for successful assessment of TAR book (Crew) record book of the approved shipboard training.
(d) All supporting documents necessary to prove experience and essential qualifications are required to be submitted at the time of filing online application. The same shall be verified at the time of documents verification, pre-appointment formalities and thereafter Indian Navy reserves the right to issue provisional Offer of Appointment only after vetting, scrutiny of and completion of verification of all supporting documents with relevant authorities.
